Qualified expenditures qualify for tax credits. In order for purchases and rentals to qualify, they must be purchased and/or rented and used in the state. In order for wages to qualify, all services must be performed in the state.

5% UPLIFT TAGGING – Non-Independent Productions only:

- Visual Effects (VU) and Music Scoring & Track Recording (MU) expenditures that qualify for the 5% additional tax credit are indicated in GREEN. Visual Effects (VU) expenditures indicated in GREEN also qualify for jobs ratio bonus points.
- "Outside the Zone" (OZ) expenditures include prep, shoot, and strike periods as long as they are incurred Outside the Zone and related to Principal Photography (PP) and/or Reshoots. (Does not apply to 2nd Unit / <u>Visual Effects / Stunt Units</u>).
 - WAGES: All wage related budget lines for outside the zone (OZ) labor should be tagged (ZW) in addition to (QW).
 - NON-WAGE EXPENDITURES: OZ Qualified Non-wage Expenditures are calculated by subtracting your Post Production, Insurance and Legal Costs (PST) from your (QE) group and pro-rating by the number of PP days in relation to total PP days. All qualified costs in those categories must also be tagged (PST).
 - OPTIONAL: Once prep begins, OZ total consumables (e.g. gas, hotel rooms) may be tracked with
 ZC. ZC expenditures will not be prorated; applicants will get 100% of the cost toward tax credits. A list of total consumables can be found in the Guidelines Appendix A (ZC are not factored into the initial tax credit estimation).
