# **CALIFORNIA FILM COMMISSION UPDATE**

The California Film Commission (CFC) looks forward to helping our motion picture community resume its work creating films and television programs that entertain, inform, and inspire people around the world.

Thanks to the efforts of California Government Leadership, Legislators and Stakeholders, the next film and TV tax credit program - Program 3.0 - is set to begin July 1, 2020. Under normal circumstances, the CFC would hold the initial allocation period in May and issue tax credit allocation letters (CALs) on July 1st. However, due to COVID-19 stay-at-home orders, we have delayed the initial application/allocation periods for Program 3.0 as follows:

### **Application Periods**

Recurring and Relocating TV Series: June 22-24

Feature/Independent Films: July 13-15

### **Credit Allocation Letter Dates**

Recurring and Relocating TV Series: July 20

Feature/Independent Films: August 17

Please note: The application periods listed above are reduced to 3 days, and each will be followed by a 5-day period during which all documentation must be submitted. The CFC will not accept any new television projects during the TV application period, as the recurring TV category is oversubscribed. Recurring TV series will receive credit allocation letters upon submission of pick-up orders. The above schedule is subject to change due to COVID-19 and approval of Program 3.0 regulations by the Office of Administrative Law.

Please visit the "Tax Credit" section on the <u>CFC website</u> for detailed information about Program 3.0. New features include: additional tax credits for local hire labor; a pilot skills training program to train individuals for careers in the motion picture industry; new bonus point categories to help projects elevate their Jobs Ratio score; and revisions to expenditure classifications which affect wage vs non-wage tagging. The <u>Program Guidelines</u>, <u>Qualified Expenditure Chart</u>,

and <u>Tracking Tips</u> have been revised in great detail to explain the requirements of the new program and changes from Program 2.0. The application portal has also been enhanced to accommodate new requirements under Program 3.0. Please keep an eye out for a separate production alert regarding a CFC Program 3.0 webinar, application portal tutorial and help guides.
